

Paperwork and closing costs need to be considered and accounted for when purchasing a property. To be prepared, refer to this checklist and always have these available so when you find the perfect investment property, you're ready to go!

## Paperwork Checklist



#### **Income Verification**

Last two T4s/W-2s
Last two Paystubs
<b>Employment Letter</b>

- ☐ Last two or three Income Tax Returns
- ☐ Tax assessments and permission forms signed for access by lender

#### Self-employed (if applicable):

- ☐ Profit and loss statements
- ☐ Last two or three Federal Tax Returns (personal and business)
- List of business debts
- ☐ Form used to report income and file taxes
- ☐ Written explanation for any employment gap

### Alimony/Child Support (if applicable):

- ☐ Copy of court order
- ☐ Bank statements or cancelled cheques

#### **Assets and Debts**

#### Debts:

- Monthly debt statements

   (auto loans, student loans, credit cards, existing mortgages)
- ☐ Documentation of any large deposits
- Judicial decree or court order for each obligation due to legal action

#### Assets:

- Last two to three statements from any investment accounts (retirement accounts, stock investments, certificates of deposit)
- ☐ Gift letter

#### 1 Credit Verification

- Credit score
- Credit explanation letter for any late payments, collections, judgements, other derogatory items
- ☐ Bankruptcy/discharge papers
- ☐ Thin credit file (if applicable)



#### **Other Records**

- ☐ Divorce decree (if applicable)
- ☐ Permanent residency/immigration status (if applicable)

#### Rent:

- ☐ Proof of payments (last 12 months)
- Landlord contact information
